Dear Attorney-General

Australian Lawyers for Human Rights (ALHR) congratulates you on your appointment as Attorney-General. We are encouraged by some of your early comments around the Charter of Rights consultation reported in December media last year and support your comments on the death penalty during the election campaign.

ALHR is extremely supportive of the recent decision to sign the Optional Protocol to the Convention Against Torture which we confirmed in a media release, and in an <u>interview</u> on ABC NewsRadio.

Who we are

Australian Lawyers for Human Rights Inc (ALHR) was established in 1993, and incorporated as an association in NSW in 1998 (ABN 76 329 114 323).

ALHR is a network of Australian lawyers active in practising and promoting awareness of international human rights standards in Australia. ALHR has a national membership of over 1,300 people, with active National, State and Territory committees.

Through training, information, submissions and networking, ALHR promotes the practice of human rights law in Australia. ALHR has extensive experience and expertise in the principles and practice of international law, and human rights law in Australia.

ALHR is a member of the Australian Forum of Human Rights Organisations. It is a member of the Commonwealth Attorney General's NGO Forum on Human Rights, and the Department for Foreign Affairs Human Rights NGO Consultations.

Issues addressed by ALHR include anti-terrorism laws, refugee and migration issues, proposed reforms of the Human Rights and Equal Opportunity Commission, amendments to anti-discrimination laws, and Australia's National Human Rights Action Plan.

To help lawyers use human rights remedies in their daily legal work, ALHR runs seminars on the use of international human rights standards in daily legal practice, in areas such as family law, tenancy, anti-discrimination, crime, corporations, land and environment, and employment. We have recently commissioned a training package that we hope to role out to articled clerks and APS graduate intakes.

ALHR priorities

This letter outlines a number of areas which ALHR considers to be priorities for reform in your new portfolio.

Attached to this letter is a short summary of actions taken by ALHR during the last twelve months that relate to your portfolio, and an agreed list of priority areas for 2008. ALHR submissions and media releases can also be found on our website: www.alhr.asn.au.

In summary, our recommendations for reform are as follows:

- ALHR believes that the key to an enduring commitment to maintaining a peaceful and democratic society is the development of a culture of human rights that respects the inherent dignity of all human beings. ALHR is committed to the establishment of a Charter of Rights at the Commonwealth level, which would complement legislative efforts already made in the ACT and Victoria, and which are also under active consideration in WA and Tasmania.
- ➤ ALHR congratulates the Rudd Government on its election commitment to initiating a consultation process about how best to promote and protect the rights of Australians, and ALHR's membership of 1300 legal professionals looks forward to contributing to the consultation when announced. We ask the Government to resource a nation-wide celebration of the 60th anniversary of the Universal Declaration of Human Rights in December 2008.
- ➤ ALHR believes that Australia should immediately signal acceptance of the UN Declaration on the Rights of Indigenous People 2007 as a priority, and that full implementation of the goals of the Declaration should be achieved by the year 2020.
- ALHR believes that ensuring the wellbeing and realising the rights of indigenous Australians is the most important human rights challenge Australia faces. ALHR supports the 'Close the Gap' Campaign for Indigenous Health Equality as a priority human rights issue (http://www.closethegap.com.au/).
- ➤ ALHR welcomes the review of the Northern Territory emergency intervention. The future rights of Indigenous Australians cannot be addressed by the application of racially discriminatory laws.
- ➤ ALHR supports the 58-08 campaign to repeal federal laws which discriminate against same-sex couples (http://www.glrl.org.au/58/). ALHR seeks the eventual recognition of same-sex unions in every State and Territory.
- ALHR supports the full implementation of the UN Convention on Disabilities into Australian domestic law. We would urge the Government to expedite that process so that Australia can be in a position to provide input into the selection of the treaty body.
- ➤ ALHR recommends that Australia sign as a matter of urgency the Optional Protocol to the Convention on the Elimination of all forms of Discrimination against Women (CEDAW). Australia needs to ensure equal pay for women, protection from all forms of violence, paid maternity leave and equal political representation for Australian women.

- ➤ ALHR welcomes the Rudd Government's policy focus on homelessness and insecure housing in Australia and hopes that the White Paper process will bear fruit. ALHR is anxious that homelessness is seen as a human rights/social exclusion/lack of citizenship rights issue, not just a welfare or charity issue.
- ALHR welcomed the Government's announcement that Australia will sign the Optional Protocol to the Convention against Torture (CAT), and will clarify the criminal sanctions against torture in Australian law.
- ➤ ALHR believes that the counter-terrorism laws passed since September 2001 permit significant human rights breaches and need to be reviewed and amended to achieve compliance with our international obligations.
- ALHR welcomed the Government's signing of the Kyoto Protocol, and asks that a full assessment of the human rights impacts of climate change for Australia, including 'climate refugees' from the region, be made a matter of urgent policy review.
- ➤ ALHR supports the repeal of mandatory, indefinite detention from the Migration Act, the repeal of the excision regime and the closure of the Christmas Island detention centre. Generally, ALHR believes that immigration matters involving Australia's obligations under the 1951 Refugee Convention should be subject to final clearance by the Office of International Law in your Department.

We would welcome the opportunity to discuss these recommendations and concerns with you and your advisers and to elaborate further on the detail.
