The Hon. Michael Kirby AC CMG will talk at the College of Law about his work as Chair of the UN Commission of Inquiry on Human Rights in Democratic People's Republic of North Korea.

On 21 March 2013, the United Nations Human Rights Council (HRC) established the Commission of Inquiry (COI) on Human Rights on the Democratic People's Republic of Korea (DPRK) (North Korea). The Commission was established by HRC Resolution A/HRC/RES/22/13. This mandated the COI to investigate the systematic, widespread and grave violations of human rights in the DPRK so as to ensure full accountability, in particular, for violations that may amount to crimes against humanity.

The Hon. Michael Kirby AC CMG was named as one of the Commissioners of the COI and will talk at the College of Law about his work as Chair of the UN Commission of Inquiry on Human Rights in Democratic People's Republic of North Korea.
